The Staff and Friends of Southern Cross University Giving Program was established to raise funds for important initiatives that advance the mission of the University and contribute to wider community benefit.

The **Staff and Friends of the University Giving Program** will raise funds for the following:

- ★ Rising Stars Scholarships – undergraduate, internship or postgraduate scholarships
- ★ Alumni Scholarship – a postgraduate scholarship for Alumni of Southern Cross University
- ★ Rebecca Coyle Memorial Scholarship – an Honours scholarship for a student enrolling in a School of Arts & Social Sciences honours program. Preference will be given to students focussed on the area of audio – visual interaction, for example screen sound.
- ★ Louise Morgan Memorial Scholarship – an undergraduate scholarship

- ★ East Timor Project – to support the University’s work in Timor-Leste with community capacity building.

**Staff Giving** – The giving program allows you to contribute in a way which suits you, from a one- off donation to a regular payroll deduction.

*One-off donations:* simply complete this form and forward it with a cheque to the address above or take it directly to the cashier at your SCU campus.

*Payroll deductions:* The University offers **staff** a payroll deduction option, enabling you to give generously through fortnightly payments. You can choose to complete this form and send to the address above **OR** it can now be self managed on the MyHR Self Service Program. Select [My Payroll Details] - [Ongoing Deductions] - [New] - [Staff Giving - Program] for the projects listed on this form. Payroll deductions will be recorded **post tax**. The amount of your total annual gift will be printed on your group certificate at the end of the financial year for tax purposes.

All gifts are voluntary and qualify for tax deductibility.
