Maximum Duration of trip: 180 days (commencing the date you depart and return to Australia)

Activities: Travel is covered for curriculum related activities. That is, travel which is

directly linked to the completion of your enrolled degree. Travel needs to

be approved by the University prior to your departure.

Aggregate Limit: If a group of more than 20 students are travelling together, the trip

organiser should contact the insurance office as aggregate limits may

apply.
